1. Voice Plan: Sprint Nextel National Flat Rate Business Plan

The National Flat Rate Business Plan is at a **\$4.00** monthly recurring charge and a **\$.05** flat per minute rate with no termination fee. The plan includes voice mail, caller ID and call waiting but there are no included plan minutes. Call forwarding is not included and is at an additional cost. Call forwarding should not be used unless there is a valid business need. The per minute rate is applicable to all calls (peak, off-peak, mobile-to-mobile, direct connect).

2. Blackberry Plan:

The Blackberry Email and Web Plan (EVDO phones) is at a **\$19.99** monthly recurring charge and requires activation of the **\$4.00** Flat Rate Business Plan with a **\$.05** flat per minute rate as described above and also includes unlimited BlackBerry email and Web.

3. Sprint Nextel CDMA EV-DO and EVDO Rev-A Connection Cards Data Plan

4. Text Messaging

There are three different plans to send and receive SMS text messages picture and audio messages from your Sprint Nextel phone, any email address or through Sprint Nextel.com.

- Pay-As-You-Go Messaging - messaging at a cost of **\$.20** per message (inbound and outbound).
- Text Messaging 300 Plan – at a monthly recurring charge of **\$3.75** this includes 300 text messages and pay-as-you-go image/audio messages at a cost of **\$.20** per message.
- Unlimited Text Messaging Plan - at a monthly recurring charge of **\$15.00** this includes unlimited text messaging and pay-as-you-go audio/image messaging at a cost of **\$.20** per message.

5. Wireless Priority Service (WPS)

WPS allows authorized National Security and Emergency Preparedness (NS/EP) personnel to make cellular calls during an emergency when channels may be congested. WPS is overseen by the National Communications System (NCS) a division of the Department of Homeland Security. NCS will inform Sprint Nextel of those subscribers that are approved for WPS and at what Priority Level. Sprint Nextel cannot add, delete or modify a WPS subscription without NCS consent. WPS has a monthly recurring charge of **\$4.50** per wireless telephone number and a **\$.75** per minute charge when WPS code is used.
