## **MINUTES OF PREVIOUS MEETING:**

All board members present today reviewed the draft May 8, 2014 minutes and further discussion of its wording took place. Also present at today's meeting was Bill Warzecha, state geologist from DEEP, who went into greater detail on the geological aspects of this Superfund Site. Furthermore, discussion ensued pertaining to number of wells, types of contamination, and abandonment requirements.

A motion was made to accept the draft minutes of May 8, 2014 meeting specifically pertaining to the section under Old Business, Item #1 entitled "Request for exemption pursuant to Sec. 25-133 of Title 25 of the State Well Drilling Board Rules and Regulations." The Board voted to approve this motion. Joyce Topshe, Anthony Calandrino, and Chris Bowman were in favor. John Damico and George Sima opposed. Melissa Sheffy abstained.

### **Antonio Verderame**

Antonio Verderame appeared and received guidance by the Board regarding the licensing process for the (P-2) Unlimited Journeyman license. He currently holds an (S-1) Unlimited Contractor license.

## **APPEALS:**

### **John Royce, Eastchester, NY – (P-1) Unlimited Contractor – Denied**

Mr. Royce was denied on May 8, 2014 due to lack of the required (P-2) Unlimited Journeyman license for a period of two years. Additional documentation was submitted for the Board to review.

At today's meeting, the Board voted unanimously to deny Mr. Royce's application due to lack of the required (P-2) Unlimited Journeyman license for a minimum of two years.

## **APPLICATIONS:**

### **Justin Ivey, Cheshire, CT – (P-2) Unlimited Journeyman – Conditional approval**

The license type applied for is a (P-2), however, documentation submitted is most closely related to the (SP-2) license type. The Board voted unanimously to approve Mr. Ivey's application, contingent upon Mr. Ivey changing the license type sought from a (P-2) to an (SP-2).

### **Shaun Rodrigues, Sr., Riverside, RI – (P-1) Unlimited Contractor – Denied**

The Board voted unanimously to deny Mr. Rodrigues' application due to lack of the required (P-2) Unlimited Journeyman license for a minimum of two years.

### **Thomas Daggett, Cushing, ME – (P-2) Unlimited Journeyman – Tabled**

The Board voted unanimously to table Mr. Daggett's application pending additional information regarding related instruction.

### **Mark Morello, Clermont, FL – (P-1) Unlimited Contractor – Denied**

The Board voted unanimously to deny Mr. Morello's (P-1) application. The Board voted unanimously to conditionally approve for the (P-2) examination, contingent upon the submission of a comparative analysis completed by the Ct. Dept. of Education reflecting that education is equivalent to Connecticut P-2 requirements, submission of documentation of the required hours of on-the-job training, and appearance at the next board meeting.
