OVERVIEW OF INCIDENT

On 10/29/13, members of the CT State Police Computer Crimes Unit served an arrest warrant for the accused and charged him with Possession of Child Pornography in the First Degree, 53a-196d. The investigation against the accused was initiated in October of 2012 after receiving a CyberTipline report from the National Center for Missing and Exploited Children. The report described how a computer repair technician had remotely accessed the accused's computer and observed what he believed was child pornography. On 11/28/13, members of the CT State Police with the assistance of the Branford Police Department executed a search warrant at the accused's residence and seized a computer. An examination of the computer was conducted and images of suspected child pornography were located.
