



## **Legislative Update # 26 July 15, 2011**

The Legislature has the authority to schedule public hearings on any part of the plan. If public hearings are scheduled, we will send out another update. ### **Summary of DMHAS budget reductions**

- Closure of the detox unit and two male substance abuse rehabilitation units at Merritt on the CVH Campus. This plan keeps the STAR Program at CVH, and the 42 substance abuse treatment beds on the Blue Hills campus.
- Eliminates the CVH Fire Department
- Eliminates 83 administrative and supervisory positions across DMHAS
- Takes into account 84 projected retirements over the next fiscal year
- Sweeps 246 department vacancies and additional 8 vacancies in the Young Adult Services Program (YAS)
- Reduces new dollars allocated for expansions in YAS, Acquired Brain Injury (ABI) and Home and Community Based Waiver (HCBW) programs
- Reduces 1.8 million in the DMHAS Behavioral Health Recovery Support Program
- Will require DMHAS and DSS to explore a Medicaid Waiver for our Medicaid Low Income Adult population projecting significant savings in the second year
- Eliminates new dollars designated to CLRP
- Reduces 300 thousand dollars in Supportive Housing Services due to delayed start up
