1. Call to Order

1.1 The meeting was called to order at 10:12 a.m. by Commissioner Reviczky and introductions followed.

2. Meeting Minutes Approval

2.1 A motion was made by Ms. Linda Auger to accept the October 10, 2014 minutes as submitted. The motion was seconded by Mr. George Motel. The motion passed unanimously without discussion.

3. Financial Report

3.1 Ms. Smith provided a financial report.

4. Chairman's Report

4.1 Chairman Reviczky commented on the budget and noted that at this time no recensions have been made in the agency budget.

5.1 Passport Subcommittee

5.1 The recommendations to the 2015 Passport were presented by Mr. Jim Frey and discussed. Action on the items

will take place during New Business.

- 5.2 Ms. Michele Niedermeyer suggested that a white paper document be created to propel the program.
- 5.3 There was also discussion on working with a UConn graduate student on the multiplier effect of the program on tourism and other industries.

6. Big E Subcommittee

- 6.1 Mr. Jonathan Edwards gave an overview of the outcomes from the 2014 Big E.
- 6.2 DAS has yet to invoice the agency/Council for a number of expenses. Once all expenses are accounted for there will be approximately \$10,000 remaining in the budget from the booth build out.

OLD BUSINESS

7. Public Comment Period Regarding Old Business (5 minutes)

- 7.1 Mr. Bob Chipkin commented that it should be tracked if wineries with the Connecticut Grown logo receive more stamps than wineries without the logo. It would provide baseline data into the effectiveness of the Connecticut Grown Designation Program.

8. 2014 Passport Redemption Results

- 8.1 Ms. Jaime Smith reviewed the 2014 Passport Program redemption results and estimated economic impact to each winery.

NEW BUSINESS

9. Public Comment Period Regarding New Business (5 minutes)

- 9.1 Mr. Chipkins commented that the Passport Program is an excellent one and the Connecticut Grown Designation Program isn't needed.

10. 2015 Passport RFP Results

- 10.1 The three RFP's received for production of the 2015 Passport were reviewed. It was determined that more clarification is needed and Ms. Smith will go back to Northeast Printing Network to inquire about the details of their bid in hopes of reducing the overall costs.

11. Action of Passport Subcommittee Recommendations for the 2015 Passport Program

- 11.1 The recommendations by the Passport Subcommittee were briefly reviewed and Mr. Frey made a motion to accept the seven recommendations. Mr. George Motel seconded the motion.
- 11.2 Discussion on the recommendations followed and it was suggested recommendation number seven be modified to read: Your Passport may be disqualified if it is altered or embellished in any way. There was extensive discussion on the continuation of the Connecticut Grown Designation Program.
- 11.3 A motion was by Mr. Frey, seconded by Dr. Frank Ferrindino, to amend the standing motion by modifying recommendation seven as suggested and remove recommendation six regarding the Connecticut Grown Designation Program. There was no subsequent discussion. Chairman Reviczky called for a vote on the motion to amend, and it passed with nine yeas and one nay from Mr. Motel.
- 11.4 Chairman Reviczky called for a vote to approve the initial motion, as amended by the second motion, and it passed unanimously.
- 11.5 Discussion took place on the recommendation regarding the Connecticut Grown Designation Program. A motion was made by Ms. Niedermeyer, seconded by Mr. Motel, to add the word 'voluntary' to the Connecticut Grown Designation Program. There was additional discussion and the motion passed with 8 yeas and 2 nays from Mr. Frey and Mr. Edwards.
- 11.6 Ms. Niedermeyer suggested that ideas on how to promote grape growing be added to the March agenda.

12. Agency Support and Time Allocation

12.1 Chairman Reviczky discussed the future of the agency support and overall time allocation that will be provided to the Connecticut Farm Wine Development Council given agency retirements and changes to program assignments.

13. 2014 Passport Drawing


13.1 The drawing for the 2014 Passport Program winners were drawn. The complete list is included below.
