**Notes:**

- (1) The fiscal year 1994 Off-Track Betting revenue figure includes \$906,018 transferred from Fund 1110, which was used to account for OTB activity prior to the sale of the system to a private operator on July 1, 1993, in addition to \$4,882,157 from Fund 7016, consisting of tax payments by the new operator during the year.
- (2) P.A. 96-212, effective July 1, 1996, established the Connecticut Lottery Corporation to operate and manage the lottery. The fiscal years 1997 through 2008 lottery figures comes from the Connecticut Lottery Corporation's audited financial statements, which show General Fund transfers as one lump sum rather than by game.
- (3) Connecticut Jai Alai, Inc. (Milford Jai Alai) ceased operations December 12, 2001.
- (4) Plainfield Greyhound Park ceased live racing on May 14, 2005.
- (5) Shoreline Star Greyhound Park ceased live racing on October 10, 2005 and was acquired by Autotote Enterprises on April 5, 2006. Autotote Enterprises decided not to run live racing.
