# CONNECTICUT DEPARTMENT OF PUBLIC HEALTH REGULATORY ACTION REPORT QUARTER 1 2005

## STATE REGULATIONS APPROVED

The following regulations were approved by the Legislative Regulation Review Committee:

**Emergency Distribution of Potassium Iodide** – To amend the administration of medication regulations for youth camps, child day care centers, group day care homes, family day care homes and nursing homes located within and Emergency Planning Zone (EPZ) which will permit specified staff to distribute potassium iodide during a declared emergency.

**Effective: January 4, 2005**
