STATE REGULATIONS APPROVED

The following regulations were approved by the Legislative Regulation Review Committee:

Feeding Assistants – (A) The purpose of the regulation is to make existing regulations consistent with 42 CFR parts 483 and 488 which allow long-term care facilities to use feeding assistants to perform this single patient activity of daily living under certain conditions. (B) The proposed regulation will allow individuals who have completed a state-approved feeding assistant training program to orally feed patients who do not have complicated feeding problems. Feeding assistants do not perform any other nursing or nursing related tasks; and they shall not be included in nurse staffing requirements and shall not substitute for nurse aide staffing. (C) The proposed regulation amends section 19-13-d8t of the Regulations of Connecticut State Agencies.

Effective: May 1, 2007

Services Offered by Homemaker Home Health Aide Agencies – (A) The purpose of the regulation is to make existing regulations consistent with Public Act 05-64. (B) The regulation will require a patient assessment by a homemaker home health aide agency at least every sixty days by a registered nurse and that the assessment be performed while the homemaker-home health aide is providing services in the patient's home. (C) The regulation will amend subsection (e) of section 19-13-D82 of the Regulations of Connecticut State Agencies.
