# CONNECTICUT DEPARTMENT OF PUBLIC HEALTH REGULATORY ACTION REPORT QUARTER 1 2008

## STATE REGULATIONS APPROVED

The following regulations were approved by the Legislative Regulation Review Committee:

### **Adverse Event Reporting for Hospitals and Outpatient Surgical Facilities - Statement of Purpose:**

(A) The purpose of the regulation is to comply with section 19a-127n of the Connecticut General Statutes which mandates the development of regulations for the reporting of adverse events occurring within hospitals and outpatient facilities. (B) The proposed regulation will establish procedures for reporting adverse events and identify a list of adverse events that are in addition to the National Quality Forum's List for facilities mandated to comply with section 19a-127n of the Connecticut General Statutes. (C) The proposed regulation will add section 19a0127n-1 and 19a-127n-2 to the Regulations of Connecticut State Agencies.

**Effective: October 29, 2007**
