SUMMARY OF INCIDENT OR AFFIDAVIT: <input checked="" type="checkbox"/> ARREST MADE <input type="checkbox"/> UNDER INVESTIGATION On 04/06/05, approx. 8:17 p.m., Troop D was notified that Burrville, R.I. Police and Douglas, MA. Police had pursued a vehicle into Putnam, CT. from Burrville, R.I. (bordering town). The operator of the vehicle was suspected to be highly intoxicated and he was also a suspect for leaving the scene of a serious injury motor vehicle accident that had occurred during the evening of 04/05/05 in Gloucester, R.I. (also a bordering town). Troop D troopers were not involved in the actual pursuit of the vehicle but they did terminate the pursuit at the intersection of Rts 44/21 in Putnam, CT. by deploying "stop sticks", which flattened the tires of the suspect vehicle. The operator (Stanley Bouchard) was then arrested by Troop D troopers, with assistance by Burrville and Douglas officers, after he violently resisted their efforts. Troop D charged Bouchard with D.W.I., Disobeying the Signal of an Officer, and Operating with a Suspended License; as well as Interfering with Police and Breach of Peace. He was held overnight at Troop D in lieu of \$50,000 bond. On 04/07/05, approx. 10:00 a.m., Troop D learned that Gloucester, R.I. Police had obtained a felony arrest warrant in their state charging Bouchard with Leaving the Scene of an Accident Resulting in Serious Bodily Injury. This warrant was issued in connection with the 04/05/05 hit and run accident in Gloucester, R.I. Gloucester Police reported that they were willing to extradite Bouchard back to Rhode Island to face the R.I. felony charge. CSP Eastern District Major Crime detectives charged Bouchard with being a Fugitive From Justice and held him in lieu of a \$100,000 bond. Bouchard was presented at Danielson Superior Court, GA #11, on 04/07/05 to face all of the aforementioned charges. The victim of the R.I. hit and run accident (a 41 year old female) remains in extremely serious condition at UMASS Medical Ctr., Worcester, MA.
