BRIEF DESCRIPTION OF ACCIDENT

Vehicle # 1 was traveling west on Rt. 82 slowing for the stop sign at the intersection with Rt. 149. Vehicle # 2 was traveling east on Rt. 82 and crossed left of the double yellow line, colliding with vehicle # 1 head-on. Operator # 2, Paula Lammlin, dob 9/14/46, was pronounced deceased at the scene. This case is under investigation.
