

The contract between Child and Family Agency of Southeastern CT, Inc. ("Contractor") and the Connecticut Department of Social Services ("Department"), which was last executed by the parties on May 12, 2015 is hereby further amended as follows:

1. The total maximum amount payable under this contract shall be decreased by \$4,000 from \$212,000 to \$208,000. This decrease is due to SFY 2016 rescissions.
2. The budget on page 2 of amendment #1 shall be deleted and replaced in its entirety by the budget on page 2 of this amendment.

All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.


